## **Millage Rates**

Your total tax rate includes millages for schools, (Hartford Public Schools, and Van Buren Intermediate School District) other public services, (Hartford District Library, Public Transit, Hartford Fire Department, Senior Services), and Van Buren County (roads, ambulance, public safety, transit, conservation district and veteran's relief). It also includes the City of Hartford Charter Tax and the City's Sewer Debt.

The millage rate times the taxable value (per thousand) is your tax obligation.

Example: Taxable Value (\$100,000) X millage rate (24.3395/1000) = \$2,433.95
